













INTEGRATION POLICIES WHO BENEFITS?

Lower 'brain waste' & increase access to AT training, degrees & public sector jobs Restrictive policies keep apart AT's small number of transnational families Schools slow to respond to migrant pupils' specific needs & opportunities Regional migrant health practices yet to come together as coherent national policy Non-EU citizens disenfranchised & disengaged in this exclusive democracy Restrictive & outdated policies keep many from becoming permanent residents & citizens Poor awareness of discrimination/rights & weak support undermine access to justice WWW.**MIPEX.**EU
